## Office of the Deputy Commissioner Budgam

**Subject:- Minutes of Meeting Regarding Mysterious Blast Occurred at Tosamaidan Meadow on 12-08-2018.**

A meeting under the chairmanship of Deputy Commissioner Budgam was held on 12-08-2018 to discuss the immediate measures to be taken for the safety of tourists/local population.

The following officers/Non-officials attended the meeting:-

At the outset, Deputy Commissioner Budgam appreciated the efforts of the officers for their quick response and for providing all necessary help to the family of deceased and injured persons. The chair informed that District Administration will bear all the medical expenses of persons who got injured in blast that has occurred on 12-08-2018 at Tosamaidan and will provide all possible help by the Administration. The chair thereafter sought feedback from the representatives of Tosamaidan area.

The locals of Tosamaidan apprised the chair that they have very clear doubt that the mine may have been planted and they want investigation into the said incident as the explosive seems quite fresh. Besides they demanded that a fresh demining drive shall carry out in Tosamaidan area with the help of locals.

SDM Beerwah apprised the chair that FIR has been lodged into the said incident by the concerned police authorities. He further apprised that post mortem was not allowed by the family of the deceased person.

After having threadbare discussions with all the stake holders following decisions were taken:-

1. Chief Executive Officer Tosamaidan Development Authority shall install signages mentioning not to touch or fiddle any unidentified/suspected object in the area. He was asked to direct Tourist guides/shopkeepers for guiding the tourist not to touch any unidentified object.

2. Addl. Deputy Commissioner Budgam shall ensure that advisory be issued in the area through CEO Tosamaidan Development Authority.

**(Action by: ADC/CEO TDA)**

3. Headquarter Assistant with Deputy Commissioner shall obtain the copy of FIR from the concerned police authorities.


**(Action by: HQA)**

4. CEO Tosamaidan Development Authority was asked to explore the possibility of telecommunication services in the area and take the necessary steps in this regard with the concerned agencies.

**(Action by: CEO TDA)**

At the end Deputy Commissioner assured that after getting report from Police and Revenue Department, if need arises matter will be taken with the concerned authorities for appropriate necessary action.
