Subject: Imposition of Section 144 under Cr. PC in District Budgam


ORDER NO: 124 /PS OF 2017
DATED: 16 02 / 2017

Whereas, it has been generally observed in a number of cases in the recent past that during the counter-insurgency operations, a good number of people from the adjoining areas / localities tend to move to the site of operation, thereby, putting their lives to avoidable risks.

In view of the above, it has been felt that it may be expedient to impose reasonable restrictions around the site of operation for safety and security of the general public, as an anticipatory measure.

Now, therefore, in exercise of powers vested in me, under section 144 Cr. P.C. I, District Magistrate, Budgam hereby impose restriction on the movement of people within the radius of 03 kms from the site of any counter- insurgency operation. In case of any exigency, the local population can seek the assistance of the District Administration or the local Police concerned. These restrictions shall, however, not apply to the movement of Ambulances/ Medical/ Para-Medical Staff/ Government Employees.

This order shall remain in force for a period of two months from the date of its issue or till further orders, whichever is earlier.



However, these restrictions shall not apply to the movement of ambulances / medical / paramedical staff/ Govt. employees
